Agenda Item: Public Comment

Agenda Item: Approval of Minutes from October Meeting

Agenda Item: Long Range Planning

We reviewed the overview of the Management Plan

Kathy would like the committee to make the town aware of the recreational opportunity at Shiloh Pond. She suggested we submit a letter into the town's annual report and have the same information on the town website.

Brent suggested we have a simple map on the town website and also highlight the people who volunteered or donated materials on the town annual report.

Stacey will draft a document for educators and one for families to be sent home from school, both about Shiloh Pond and suggested activities.

Brent raised the topic of maintaining a section of the Tuft's Pond Road, between Grindstone Pond Rd and the road to Shiloh Pond. In particular, improving the ditches, and back and grading the road. He suggested we get some estimates from local businesses such as Fenwicks. He noted that we have \$15,000 for road maintenance. There are other possibilities for getting the work done such as renting equipment, borrowing equipment, and community contributions of materials and labor. All the work could be done with a mini-excavator.

Rob explained that it is not possible to make improvements to the road surface under the ongoing wet conditions.

Kathy raised the topic that someone continues to leave their large, metal boat on the shore, even though she has left two letters taped to their boat, asking that they not leave it on the shore. The group decided that if it happens again, we will call the game warden to deal with it.
